## Election Procedure of IMR Alumni Association Board of Directors 2024

### 1. Election of Members of Board of Director IMR Alumni Association:

There will be 15 members of the Board of Director of IMR Alumni Association as per the constitution.

- i. If more than 15 Applications are received from the eligible members, election will be held through ballot paper with names of candidate.
  - a. Members present in the meeting will vote for maximum 15 candidates.
  - b. Based on highest votes first 15 candidates will become new Board members.
  - c. In case of tie between the candidates, members will be selected by drawing lucky chits.
- ii. In case of receiving less than 15 applications, all the applicants will be selected unopposed as members of Board of Director.

The remaining vacancies in the Board of Director can be filled up from the present members with consent of majority in the same AGM.

- ### 2. Election of office bearers:
- The office bearers are to be nominated and selected by the newly elected board members amongst themselves in the succeeding board meeting.

- The tenure of new board will be up to 2029.
