Supplementary Examinations - August 2026

For all PG students (MBA, MBA (Pharmaceutical Management), MCA) seeking supplementary examinations

The Final year students of all PG programs (MBA, MBA Pharmaceutical Management, MCA) who are interested in applying for supplementary examinations for the academic year 2025-26 are hereby notified that supplementary exam form link will be made available on student portal.

Only regular final year students of MBA, MBA Pharmaceutical Management, MCA programs for academic year 2025-26 can apply for **semester I, II, III & IV**. Only eligible students can apply.

Rules for Supplementary Examination :

1	Only Final Year Students (MBA, MBA Pharmaceutical Management, MCA) : are eligible to apply for Supplementary Examination.
2	Only Final Year students (MBA, MBA Pharmaceutical Management, MCA) who have either failed or were absent for the 1st, 2nd, 3rd and 4th semester examinations (Internal, External Theory and Practical/ OJT/RP) are eligible for the Supplementary Examination.
3	Only regular final year students who submitted their regular Last Semester examination forms are allowed to apply for the supplementary exams.
4	The question paper pattern, syllabus, and weightage are the same as those of the examination in which the student has failed.
5	Students with Copy case (s) registered against them cannot apply for the Supplementary Examination.
